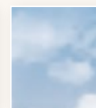

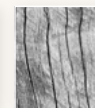

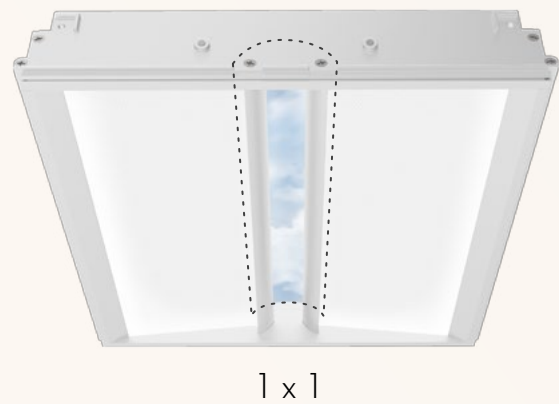

I. Hubbell Provided Content
