

Software End User License Agreement

This License Agreement ("Agreement") for SELECTSYNC™ or other software being installed and/or used ("Software") is entered into by and between Hubbell Lighting, Inc. ("HLI") and each company and/or user installing and/or using the Software ("User"). BY INSTALLING OR OTHERWISE USING THE SOFTWARE, USER AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF THE USER DOES NOT AGREE, USER MUST UNINSTALL ALL COPIES AND RETURN THE SOFTWARE.

LICENSE. HLI grants a revocable, nontransferable and nonexclusive license to User to use the Software in the United States in machine readable form on User owned and controlled computer hardware and solely for the commercial purpose as specified in the user instruction material such as for programming lighting drivers using the related peripherals. The Software may not be rented, lent or leased. All other rights are reserved to HLI and its licensors and no other right or license is granted, express or implied.

User acknowledges that at least two component license agreements will be presented to User during installation including from Future Technology Devices International Limited and from FEIG Electronic GmbH. The License granted here is conditioned on full acceptance of all such licenses presented. IF THE USER DOES NOT AGREE, USER MUST UNINSTALL ALL COPIES AND RETURN THE SOFTWARE.

Additionally, User acknowledges that certain components of the Software may be governed by third-party licenses that may also include one or more "open source" software licenses. User hereby agrees to comply with any more restrictive terms herein and any additional terms of all such licenses and all updates thereto. Solely to the extent the terms of the third-party licenses strictly prohibit any more restrictive provisions in this Agreement, such more restrictive provisions will not apply.

USER OBLIGATIONS AND INDEMNIFICATION TO HLI.

User shall not modify, adapt, translate, prepare derivative works from, decompile, reverse engineer, disassemble or otherwise attempt to derive source code from the Software. Customer also agrees not to remove, obscure, or alter HLI's or any third-party's copyright, trademarks, or other notice. User shall not provide the Software to a third-party. User shall not make more than one installation of the Software without written permission from HLI.

User shall be exclusively responsible for the supervision, management, and control of use of the

Software, including but not limited to assuring use of the latest version of the Software, proper computer hardware configuration, program installation, and operating methods.

User shall apply with all applicable federal, state and local laws including any applicable

"Export Control Laws" including any applicable export and re-export control laws and regulations.

User agrees to indemnify, defend and hold harmless HLI and its affiliates to the fullest extent permitted by applicable law from and against any and all losses, claims, damages, liabilities, settlement costs and expenses, due to failure to meet any of User's obligations hereunder.

TERM. The term of this Agreement shall commence upon User's installation of, access to or use of the Software and terminates upon the date HLI determines end of life support. The Agreement may be terminated by either party if: (i) the other party is in material breach of the Agreement and fails to cure such breach within thirty days of notice; (ii) the other party ceases its business operations or becomes subject to insolvency proceedings and the proceedings are not dismissed within ninety days; or (iii) the other party is in material breach of this Agreement more than two times notwithstanding any cure of such breaches. Upon termination of the Agreement, the rights and licenses granted hereunder cease immediately and User shall promptly remove the Software from its systems and, if requested, certify this removal to HLI.

EXCLUSION OF WARRANTIES. USER UNDERSTANDS AND AGREES THAT ITS USE OF THE SOFTWARE IS AT USER'S SOLE RISK AND THAT THE SOFTWARE IS PROVIDED "AS IS" AND "AS AVAILABLE". HLI, ITS AFFILIATES, AND ITS LICENSORS DO NOT REPRESENT OR WARRANT TO USER THAT: (A) USER'S USE OF THE SOFTWARE WILL MEET USER'S REQUIREMENTS, (B) USER'S USE OF THE SOFTWARE WILL BE UNINTERRUPTED, TIMELY, SECURE OR FREE FROM ERROR OR MALICIOUS CODE, AND (C) THAT DEFECTS IN THE OPERATION OR FUNCTIONALITY OF THE SOFTWARE WILL BE CORRECTED. USER AGREES THAT ANY ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY USER FROM HLI OR ITS AFFILIATES OR LICENSORS DOES NOT CREATE ANY WARRANTY NOT EXPRESSLY STATED IN THIS AGREEMENT. HLI FURTHER EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES SHALL HLI OR ANY OF ITS AFFILIATES BE LIABLE TO USER ON ACCOUNT OF USER'S USE OR MISUSE OF THE SOFTWARE. HLI SHALL NOT BE LIABLE FOR DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, AND PUNITIVE DAMAGES, WHETHER SUCH CLAIM IS BASED ON WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, (EVEN IF HLI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES). SUCH LIMITATION SHALL APPLY NOTWITHSTANDING A FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY AND TO THE FULLEST EXTENT PERMITTED BY LAW. IN NO EVENT SHALL HLI BE LIABLE FOR ANY AMOUNT IN EXCESS OF THE GREATER OF THE PRICE PAID FOR THE SOFTWARE OR TWO HUNDRED FIFTY U.S. DOLLARS (US \$250.00).

INTELLECTUAL PROPERTY. User acknowledges that HLI and/or its Licensors own all rights, title and interest in and to the Software, including without limitation, all Intellectual Property Rights. "Intellectual Property Rights" means any and all rights existing from time to time under patent law, copyright law, trade secret law, trademark law, unfair competition law, and any other proprietary rights, renewals, extensions and restorations thereof, now or hereafter in force and effect worldwide.

GENERAL. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and New York State, without giving effect to the conflict of laws provisions of New York State or any other jurisdiction. For any dispute relating to this agreement, the parties consent to personal jurisdiction in, and the exclusive venue of, the courts in New York County, New York. If for any reason a court of competent jurisdiction finds any provision or portion of this Agreement to be unenforceable, the remainder of this Agreement will continue in full force and effect. Failure to enforce any provision of this Agreement shall not constitute a waiver of such provision or any other provision. User may not assign this Agreement by operation of law or otherwise without the prior written consent of HLI. The terms and conditions set forth in this Agreement constitute the entire agreement between the parties with respect to the subject matter hereof and supersede and replace all prior or contemporaneous understandings or agreements, written or oral, regarding such subject matter.
