Our Quality, Environmental and Safety Policy aims to achieve the safe and environmentally conscious sourcing, manufacture and delivery of our competitive range of products and solutions for use in harsh and hazardous environments.

Our philosophy is to build Quality, Safety and Environmental considerations into all aspects of our business relating to the design, development, manufacture and after sales servicing of:-

- Communication and control equipment incorporating telephone, audio, radio, video and IT techniques.
- Luminaires, ballasts and control gear for fluorescent, LED and discharge lamps.
- Cable glands, junction boxes and electrical and instrument connectors, adaptors and Transformer Breathers
- Electrical distribution, control and measurement equipment.

We care about and fully accept our responsibility to protect the health and safety of our people and the environment and are committed to the continual quality, environmental and safety improvement of our sites. Our commitment extends from prevention of pollution, injury and ill health, to compliance with applicable legislation and other requirements and we are committed to continuously trying to improve our OH&S performance and management system by:

- Competent people being assigned to assist in meeting statutory duties including employees with appropriate skills, local specialists and those that are employed by the Corporation to advise all Hubbell sites.
- Ensuring each individual has an understanding that they have a legal obligation to take reasonable care for their health and safety and for the safety of other people who may be affected by their acts or omissions. They must be in a fit state to carry out their job safely and not be under the influence of alcohol or drugs that could adversely affect this.

We will also continually review and improve the effectiveness of our Quality, Environmental and Safety Management System through teamwork and defined business objectives to ensure certification to the ISO9001, ISO14001, OHSAS 18001, ATEX/IECEx and other standards applicable to products used in safety critical, hazardous and arduous condition environments.
