PARTS REPLACEMENT DATA

Model 10108-001 Handset Replacement

This manual provides complete instructions for installing this handset on the following models: 755-002, -003, -004, -005, 7555-002, -003, -004, and -005, when handset cords are broken using elbow fitting, located in the side/center of the condulet box.

1. REMOVE POWER TO STATIONS BEFORE INSTALLING THIS KIT. FAILURE TO DO SO COULD RESULT IN SERIOUS INJURY OR PROPERTY DAMAGE.

Remove four (4) bolts holding the condulet box in the enclosure.

- 2. Remove the four (4) bolts holding the enclosure to the wall.
- 3. Swing the enclosure to the side and maneuver to get the maximum clearance between the elbow fitting and the inner side wall. Prop the enclosure in this position.
- 4. Remove the six (6) bolts holding the condulet cover.
- 5. Lift the cover and unfasten the four (4) wires to the handset inside the condulet box.
- 6. Use a wrench to remove the elbow fitting with the broken handset cord.
- 7. Replace with the new handset and sealed elbow fitting.
- 8. Place the four (4) handset wires in position and reconnect inside the condulet box.
- 9. Reassemble the condulet cover in position and replace six (6) bolts. Tighten to a torque of eight foot-pounds.
- 10. Remove the prop holding the enclosure and swing the enclosure back into position.
- 11. Align the enclosure holes with the condulet box and replace the four (4) bolts and tighten.
- 12. Replace the four (4) bolts holding the enclosure to the wall. Tighten all four (4) bolts.
- 13. Reapply the perma-gun where conduit nipple enter the enclosure.
- 14. Restore power to the unit.

Note: If elbow fitting is located in the lower corner of the condulet box, see GAI-Tronics Publication 42006-005.

Warranty

Equipment. GAI-Tronics warrants for a period of one (1) year from the date of shipment, that any GAI-Tronics equipment supplied hereunder shall be free of defects in material and workmanship, shall comply with the then-current product specifications and product literature, and if applicable, shall be fit for the purpose specified in the agreed-upon quotation or proposal document. If (a) Seller's goods prove to be defective in workmanship and/or material under normal and proper usage, or unfit for the purpose specified and agreed upon, and (b) Buyer's claim is made within the warranty period set forth above, Buyer may return such goods to GAI-Tronics' nearest depot repair facility, freight prepaid, at which time they will be repaired or replaced, at Seller's option, without charge to Buyer. Repair or replacement shall be Buyer's sole and exclusive remedy. The warranty period on any repaired or replacement equipment shall be the greater of the ninety (90) day repair warranty or one (1) year from the date the original equipment was shipped. In no event shall GAI-Tronics warranty obligations with respect to equipment exceed 100% of the total cost of the equipment supplied hereunder. Buyer may also be entitled to the manufacturer's warranty on any third-party goods supplied by GAI-Tronics hereunder. The applicability of any such third-party warranty will be determined by GAI-Tronics.

Services. Any services GAI-Tronics provides hereunder, whether directly or through subcontractors, shall be performed in accordance with the standard of care with which such services are normally provided in the industry. If the services fail to meet the applicable industry standard, GAI-Tronics will re-perform such services at no cost to buyer to correct said deficiency to Company's satisfaction provided any and all issues are identified prior to the demobilization of the Contractor's personnel from the work site. Re-performance of services shall be Buyer's sole and exclusive remedy, and in no event shall GAI-Tronics warranty obligations with respect to services exceed 100% of the total cost of the services provided hereunder.

Warranty Periods. Every claim by Buyer alleging a defect in the goods and/or services provided hereunder shall be deemed waived unless such claim is made in writing within the applicable warranty periods as set forth above. Provided, however, that if the defect complained of is latent and not discoverable within the above warranty periods, every claim arising on account of such latent defect shall be deemed waived unless it is made in writing within a reasonable time after such latent defect is or should have been discovered by Buyer.

Limitations / Exclusions. The warranties herein shall not apply to, and GAI-Tronics shall not be responsible for, any damage to the goods or failure of the services supplied hereunder, to the extent caused by Buyer's neglect, failure to follow operational and maintenance procedures provided with the equipment, or the use of technicians not specifically authorized by GAI-Tronics to maintain or service the equipment. THE WARRANTIES AND REMEDIES CONTAINED HEREIN ARE IN LIEU OF AND EXCLUDE ALL OTHER WARRANTIES AND REMEDIES, WHETHER EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
