



Limited Warranty

This warranty applies only to the Wiring-Device-Kellems Division of Hubbell Incorporated (Delaware), a Delaware corporation (“Hubbell”) surge protective devices (“Hubbell Product”).

I. Power Connections: The Hubbell Product should be plugged into a grounded three-prong outlet only. All connected equipment should be plugged directly into the Hubbell Product. Surges often enter and damage connected equipment through phone, cable TV, TV antenna, and data communication lines. To properly protect your connected equipment, install Hubbell Products on all incoming lines. Using an extension cord in conjunction with the Hubbell Product will void all Hubbell warranties.

II. Surge Protector Limited Lifetime Warranty

For the lifetime of the Hubbell Product, Hubbell warrants that under normal use the Hubbell Product will be free of defects in materials and workmanship. Hubbell will repair or replace, at its option, any Hubbell Product that is defective or is damaged by an electrical surge (including those caused by lightning) free of charge. This limited warranty extends through the lifetime of the Hubbell Product, which means the Hubbell Product has exceeded its capacity to protect against surges and spikes. The red indicator light will no longer be lit when this capacity is exceeded. The capacity of the Hubbell Product may be exceeded after a power disturbance. To that end, it is incumbent on you to regularly and frequently examine the Hubbell Product to ensure the red indicator light is illuminated indicating the Hubbell Product is still functioning properly.

Proper Use: If the red indicator light burns out, that indicates that the Hubbell Product has served its purpose and that it must be immediately replaced. If you continue to use the Hubbell Product **after** the indicator light burns out, then that constitutes misuse by you and this Limited Lifetime Warranty is void.

Damaged Connected Equipment Limited Warranty

THE WARRANTY COVERAGE AMOUNT IS SECONDARY TO ANY AMOUNTS RECEIVED BY YOU UNDER OTHER WARRANTIES, SERVICES CONTRACTS AND ALL INSURANCE. YOUR WARRANTY RECOVERY WILL BE LIMITED TO YOUR INSURANCE OR SERVICE CONTRACT DEDUCTIBLE WHETHER OR NOT YOU ACTUALLY RECEIVE INSURANCE OR WARRANTY PROCEEDS. THE LOSS NOT COVERED BY INSURANCE, WARRANTIES OR SERVICE CONTRACTS IS SUBJECT TO THE FOLLOWING WARRANTY LIMITS.

A. Scope

For a period of ten (10) years after you purchase your Hubbell Product, Hubbell will pay to repair or replace, at its option, with the like kind or quality, damaged equipment properly connected to the Hubbell Product at the time of the occurrence that is directly damaged by an electrical surge, provided the Hubbell Product (1) was plugged into a grounded, three-prong outlet and (2) was also damaged by the same electrical surge. Hubbell’s liability to repair or replace damaged equipment shall not exceed the amount of warranty coverage set forth above, in the aggregate for the specific Hubbell Product used. At your option, you may also receive a refund of the current depreciated value of the damaged equipment at the time of the occurrence not to exceed this limitation.

B. Exclusive Remedy for Damaged Connected Equipment

The above coverage applies to the original purchaser only, is non-transferable and is your exclusive remedy under this limited warranty, whether based in contract, tort, product liability, negligence, by statute or otherwise. Hubbell reserves the right to audit connected equipment damage, the occurrence site, and/or the cost of repairs and may request a notarized proof of loss. Claims must be made within 30 days of damage. Hubbell requires you to preserve all damaged connected equipment and the Hubbell Product for its examination, if necessary. All costs of shipping the Hubbell Product and damaged equipment to Hubbell shall be borne solely by you. (Hubbell will bear the cost of shipping equipment from Hubbell to purchaser). This limited warranty does not cover damage associated with sustained over-voltages, vandalism, theft, normal wear and tear, obsolescence, abuse, failure to ground, electrical system defects, non-authorized modification or alteration, or catastrophic events. Some states do not allow limitations on how long as implied warranty lasts, so the above limitation may not apply to you.

IV. Exclusions on Limited Warranties

The limited warranties herein do not cover (a) damages caused by acts of God, including flood, earthquake or erosion (excluding lightning); (b) damages caused by a sustained over-voltage or low voltage disturbance, including brownouts, sags or power outages; (c) damages caused by war, vandalism, theft, normal use wear and tear, depletion, obsolescence, abnormal care or uses, or abuse; (d) damaged due to a non-authorized program or system equipment modification or alteration, failure to ground or electrical system defects; or (e) damage to equipment that was not directly connected to the Hubbell Product at the time of the damage occurred.

V. Disclaimer of All Other Warranties

TO THE FULLEST EXTENT PERMITTED BY LAW, AND EXCEPT FOR THE EXPRESS WARRANTY SET FORTH ABOVE OR ANY WARRANTIES IMPLIED BY LAW, HUBBELL MAKES NO EXPRESS OR IMPLIED WARRANTIES AND DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING ALL WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE. THE FOREGOING DISCLAIMER MAY NOT APPLY TO YOU DEPENDING UPON THE HUBBELL PRODUCT YOU PURCHASE, THE APPLICATION AND USE OF YOUR HUBBELL PRODUCT OR YOUR STATUS AS A CONSUMER.

VI. Limitation of Liability

IN NO EVENT SHALL HUBBELL BE LIABLE FOR INCIDENTAL, SPECIAL, DIRECT, INDIRECT, CONSEQUENTIAL OR MULTIPLE DAMAGES ARISING OUT OF THE USE OF THE HUBBELL PRODUCT OR DAMAGE TO THE CONNECTED EQUIPMENT, REGARDLESS OF THE LEGAL THEORY ON WHICH SUCH CLAIM IS BASED, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. THE EXCLUDED DAMAGE INCLUDE BUT ARE NOT LIMITED TO, INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OF SAVINGS OR REVENUE, LOSS OF LIFE, LOSS OF USE OF THE HUBBELL PRODUCT OR THE CONNECTED EQUIPMENT OR ANY ASSOCIATED EQUIPMENT, FACILITIES OR SERVICES, DOWNTIME, THE CLAIMS OF THIRD PARTIES, INCLUDING CUSTOMERS AND DAMAGE TO PROPERTY. IN NO EVENT WILL HUBBELL’S ENTIRE LIABILITY TO YOU, INCLUDING ANY LIABILITY IN THE EVENT THE EXCLUSIVE REMEDY SET FORTH IN THIS AGREEMENT FAILS OF ITS ESSENTIAL PURPOSE, EXCEED THE AMOUNT SET FORTH IN THE ABOVE LIMITATION OF WARRANTY. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the preceding limitations or exclusions may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
