

Limited Warranty for Occupancy/Daylight Sensors and Accessories

LIMITED WARRANTY: Hubbell Incorporated (Delaware) Bryant Electric Division [hereinafter, "Hubbell"] warrants that the occupancy and daylight sensor products sold by Hubbell ["Products"] will be free of defects in workmanship or material for a period of up to sixty (60) months from the date of sale to the first non-retail purchaser [hereinafter, "Purchaser"] when stored, installed, operated or maintained in accordance with the Hubbell product specifications, standard industry practice, including compliance with the applicable National Electric Code and Safety Standards of Underwriters Laboratories, and when used under proper and normal use and specified ambient temperature. In no event shall Hubbell be responsible or liable for modifications, alterations, misapplication or repairs made to its Products by Purchaser or others. This warranty does not include reimbursement for the expenses of labor, transportation, removal or reinstallation of the Products. This warranty shall run only to the first Purchaser of a Product from Hubbell's Purchaser, or from an original equipment manufacturer reselling Hubbell's Product, and is non-assignable and non-transferable and shall be of no force and effect if asserted by any person other than such first Purchaser.

DISCLAIMER OF WARRANTY: THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES WHETHER WRITTEN, ORAL, EXPRESSED OR IMPLIED. THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS OF ANY PRODUCT FOR A PARTICULAR PURPOSE.

EXCLUSIVE REMEDY: Upon prompt written notice by the Purchaser that a Product is defective or nonconforming, Hubbell's liability shall be limited to repairing or replacing the Product at Hubbell's option. To obtain warranty performance, Hubbell must be properly notified of said defect and the authorization process must be followed completely as outlined in the Return Policy/RMA Procedures, a copy is available upon request. Defective Product must be shipped to Hubbell postage prepaid within the sixty (60) month warranty period.
