Subject to the exclusions set forth below, the Hubbell Utility Solutions entity named in the order that is providing the applicable product(s) ("HUS") warrants that commencing from the Ei Electronics LLC dba Electro Industries/GaugeTech product's date of delivery and continuing immediately following thereafter for a period of four (4) consecutive years, that the product will be free from defects in material and workmanship, and except for the foregoing, the product is sold AS IS with all faults. This warranty does not apply to defects resulting from unauthorized modification, misuse, or use of the product for any use other than electrical power monitoring, which is the intended and normal use of the product. The buyer's sole and exclusive remedy and the entire liability of HUS under this limited warranty will be, at HUS' option, as follows: (i) the product's repair; or (ii) shipment of a replacement product within the above stated warranty period. To exercise this limited warranty, the buyer must give notice to HUS' customer-support department and give additional notice to HUS' customer-support department by facsimile or by telephone for HUS' instructions for the product's return or repair. If the product is repaired, HUS will ship the repaired product to the buyer. THE FOREGOING WARRANTIES ARE THE SOLE WARRANTIES, EXPRESS OR IMPLIED, GIVEN BY SELLER IN CONNECTION WITH THE PRODUCT, AND SELLER DISCLAIMS ALL OTHER WARRANTIES, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT OF THIRD PARTY RIGHTS AND WARRANTIES AGAINST LATENT DEFECTS. The buyer must notify HUS promptly, but in no event more than four (4) years after the product's date of delivery of any claimed breach of this warranty, or such claim shall be time-barred.

PRODUCT LIMITED WARRANTY RESTRICTIONS. THE LIMITED WARRANTY CONTAINED HEREIN WILL NOT BE GIVEN OR APPLY, AND NO EXPRESS OR IMPLIED WARRANTY, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE NON-INFRINGEMENT OF THIRD PARTY RIGHTS AND WARRANTIES AGAINST LATENT DEFECTS SHALL BE DEEMED APPLICABLE, GIVEN OR PROVIDED BY SELLER WITH RESPECT TO OR CONCERNING THE PRODUCT, IF: (a) the product has been altered, except by HUS or HUS' authorized representative; (b) the product has not been installed, operated, repaired, or maintained in accordance with instructions supplied by HUS; (c) the product has been subjected to abnormal physical or electrical stress, abnormal environmental conditions, misuse, negligence, or accident; (d) the product is used in ultra-hazardous activities; or (e) the buyer failed to pay HUS the product's purchase price pursuant to the Terms of Sale.

EXCLUSIVE REMEDY: Any claim by buyer that a product is defective or non-conforming shall be deemed waived by buyer unless submitted to HUS in writing within thirty (30) days from the date buyer discovered, or by reasonable inspection should have discovered the alleged defect or non-conformity. Any warranty claim must be brought within the applicable warranty period by buyer or third party. Upon prompt written notice by the buyer that a product is defective or non-conforming, HUS liability shall be limited to repairing or replacing the product, at HUS' option.

LIMITATION OF LIABILITY. IN NO EVENT SHALL HUS BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, MULTIPLE OR PUNITIVE DAMAGES, EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES, WHETHER AS THE RESULT OF BREACH OF CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR ANY OTHER THEORY, INCLUDING WITHOUT LIMITATION LABOR OR EQUIPMENT REQUIRED TO REMOVE
